<p>SPARE LITHIUM BATTERIES</p> <p><u>Spare battery <100Wh</u> Lithium-ion batteries not exceeding 100 Wh or lithium metal not exceeding 2 g. for portable electronic devices (watches, camcorders, cameras, mobile phones, laptops, tablets, portable electronic medical devices, etc.</p> <p><u>Spare battery between 100Wh and 160Wh</u> <ul style="list-style-type: none"> • Lithium ion replacement batteries greater than 100 Wh, but not exceeding 160 Wh for portable electronic devices (<i>power tools, video cameras, drones ...</i>). • Lithium metal spare batteries between 2g and 8g <u>for medical devices only.</u> </p> <p><u>Spare battery > 160Wh</u> Lithium ion replacement batteries greater than 160Wh for electric moving gear, large power tools, electric car, etc</p> <p>EXTERNAL BATTERY</p> <p>External battery External batteries or lithium backups (Power Bank, Power Pack, battery packs...).</p> <p>FUEL CELL</p> <p>Device with fuel cells Portable electronic devices that use fuel cells, such as cameras, mobile phones, laptops and video recorders, with the manufacturer's marking "approved for carriage in aircraft cabin only".</p> <p>Replacement cartridges for fuel cells Used to refill fuel cells</p> <p><i>Note :</i> <i>The installation of a replacement cartridge is permitted but the filling of fuel cells is prohibited.</i> Maximum 2 replacement cartridges per person</p>	<p align="center">Yes</p> <p align="center">Yes</p> <p align="center">No</p> <p align="center">Yes</p> <p align="center">Yes</p>	<p align="center">No</p> <p align="center">No</p> <p align="center">No</p> <p align="center">No</p> <p align="center">Yes</p>	<p>Limited to 20 spare batteries per person. Must be individually protected to avoid short circuit.</p> <p><i>These spare batteries <u>are not allowed in the luggage</u> and must be shipped as freight.</i></p> <p>Les batteries externes sont considérées et traitées comme les batteries au lithium de rechange.</p> <p>The maximum amount of fuel in a fuel cell or a cartridges cannot exceed: - 200 ml for liquids, - 200 g for solids, <i>For liquid gas :</i> - 120 ml for fuel cells or cartridges for non-metallic fuel cells, or - 200 ml for fuel cells or cartridges for metallic fuel cells, <i>For hydrogen in metallic hydrides :</i> - The cartridges for fuel cells should have a water capacity that is less than or equal to 120 ml.</p>
